Per the Internal Revenue Service (IRS) a person is considered unmarried for this purpose if any of the following applies:

- Were legally separated according to your state law under a decree of divorce or separate maintenance at the end of 2019. But if, at the end of 2019, the divorce wasn't final (an interlocutory decree), they are considered married.
- Were married but lived apart from your spouse for the entire last 6 months of 2019 and meet the other rules under married persons who live apart.
- Were married to a nonresident alien at any time during the year and did not choose to treat him or her as a resident alien.

Paid more than half the cost to run a home in 2019 (rent, mortgage, utilities, etc.). Supported a qualifying person for at least half of 2019. A qualifying person is a child, parent, or relative who meets certain conditions that enable you to qualify for Head of Household.

If it is determined that you are legally married and filed their taxes as Head of Household for 2019 incorrectly, you will need to file an amended Federal Income Tax Return (1040X) reflecting the correct filing status. Once completed, the FAFSA form will need to be updated accordingly to reflect the 2019 amended Federal Income Tax Return.
