b) **Graduate Formula for Master of Science in Secondary Education** – Athletic Administration & Coaching (Non-Teaching) Dr. Thomas shared the admission requirements and admission formula for the Athletic Administration and Coaching Non-Teaching program. Students will have to meet the writing proficiency requirement by enrolling in PE 540 and earning a passing grade of B that is required by the Graduate School.

Writing Proficiency – Much discussion regarding standards to meet the department's writing requirement if students do not make a 3.0 on the Analytical Writing. The time is extended from meeting this requirement from one semester to give students up to two semesters. Students must earn a letter grade of B or higher.

c) Non-Thesis Option – Student on the non-thesis academic track are required to submit a softbound copy to the graduate office for review and approval. The approved copy is not required to be hardbound.
