A BILL

To amend the Higher Education Act of 1965 to provide for deferment on the repayment of loans for borrowers who are victims of sexual violence.

Sponsored by Representative Madeleine Dean (D-PA), the Loan Deferment Bill (H.R. 7980) would create a federal financial aid repayment exception for victims of sexual violence and would have the U.S. Department of Education create a Federal financial aid repayment deferment for victims of sexual violence who temporarily withdraw from college in order to seek treatment and focus on the victim's mental and physical health rehabilitation.
